


HOW TO APPLY – 2/2



1° STEP – Collect the required documents

Before the enrolment, you have to collect the following documents:

- 1) Academic qualification required for admission issued in English/Spanish/French or officially translated in Italian
 - legalized by the Italian embassy/consulate in your country (the legalization of documents is not required for Belgium, Denmark, United Kingdom, Ireland, France and Germany)
 - OR apostilled (the apostille is only available for the signatory countries to the <u>Hague</u> <u>Convention</u>)
 - OR accompanied by <u>CIMEA</u> Statement of Verification
- 2) Transcript of records (<u>list of exams and relevant marks</u>) issued English/Spanish/French or <u>officially</u> translated in <u>Italian</u>
- **3)** <u>if your title HAS NOT been obtained</u> in one of the Countries that are signatories to the <u>Lisbon Recognition Convention</u>:
 - Declaration of Value (DoV) issued by the Italian embassy/consulate
 - OR Statement of Comparability issued by <u>CIMEA</u>
 - OR Diploma supplement (if the foreign qualification is issued by an European University)

<u>if your title HAS been obtained</u> in one of the Countries that are signatories to the <u>Lisbon</u> <u>Recognition Convention</u>:

 Statement of Correspondence which can be downloaded from the <u>Automatic</u> <u>Recognition Database (ARDI)</u>.





2° STEP - Register at the Student Portal



Not registered students, will have to register at the <u>STUDENT PORTAL</u> (Reserved Area) filling in the fields with the required personal informations (<u>screenshot instructions</u>). At the end of the registration, candidates get USERNAME and PASSWORD.

3° STEP (a) - Apply

Within the 30th of September 2024, LOGIN the STUDENT PORTAL and follow the on-line procedure described in the Call for Admission and the Attachment (screenshot instructions) to apply to the relevant VOCATIONAL PROGRAM.

3° STEP (b) – UPLOAD your documents

During the application, it's necessary to **UPLOAD** the **SCAN** of the following documents:

EVERYBODY

- 1. **Application form** (the form you can find at the end of the Attachment 1 or 2 to the Call for Admission)
- 2. front-rear of the personal identification document uploaded during registration
- 3. Letter of reference
- 4. Motivational letter
- 5. Curriculum vitae highlighting any professional experience in work areas pertaining to the Vocational Program

IN CASE OF ACADEMIC QUALIFICATION RELEASED IN ITALY:

6. Self-declaration of the exams taken during the academic career

IN CASE OF ACADEMIC QUALIFICATION RELEASED ABROAD:

- **6. Academic qualification** required for admission issued in English/Spanish/French or officially translated in Italian (it is not mandatory to have the legalization/apostille/Statement of Verification if not available yet, but it will be necessary to have it, within the enrolment see STEP 6)
- 7. Transcript of records admission issued in English/Spanish/French or officially translated in Italian
- 8. if your title HAS NOT been obtained in one of the Countries that are signatories to the Lisbon Recognition Convention:
 - Declaration of Value (DoV) issued by the Italian embassy/consulate
 - OR Statement of Comparability issued by <u>CIMEA</u>
 - OR Diploma supplement (if the foreign qualification is issued by an European University)

if your title HAS been obtained in one of the Countries that are signatories to the Lisbon Recognition Convention:

• Statement of Correspondence which can be downloaded from the <u>Automatic Recognition Database (ARDI)</u> (it is not mandatory to have the DoV/Statement of Comparability/Diploma supplement/Statement of Correspondence if not available yet, but it will be necessary to have it, within the enrolment – see STEP 6).



4° STEP – Apply on UNIVERSITALY (if you need a VISA)



After submitting the application, <u>if you need a VISA</u> (check on https://vistoperitalia.esteri.it/home/en), you'll have to REGISTER and then APPLY for the relevant course, also on the **Universitaly portal** (https://www.universitaly.it/).

During the online process you will have to upload:

- 1. a passport size photo
- 2. a scan copy of your passport
- 3. **documents proving your education** (the same you've already uploaded during the application on the Student Portal).

Please note that at some point, you will be asked **which embassy or consulate** you are going to use for your VISA application.

After your application is validated by our Office, **you'll have to get in contact with your embassy or consulate**.





Within the enrolment deadline, once admitted, students have to LOGIN to the <u>STUDENT PORTAL</u> and follow the on-line procedure described in the Call for Admission and the attachments to enroll themselves correctly (screenshot instructions) to the relevant VOCATIONAL PROGRAM.

During this process, the **SCAN** of the following documents will be requested:

- 1. a good quality passport size photo
- 2. front-rear of the **personal identification document** uploaded during registration
- 3. Tax code document
- 4. **Residence Permit/Card** or **study VISA** (only required from non-EU candidates).

5° STEP (b) – Enroll

TAX CODE

Fiscal code ("Codice fiscale") is a tax identification number which is necessary to open a bank account, rent privately, buy a SIM card and apply for the residence permit.

RESIDENCE PERMIT/CARD

Non-EU citizens, when enrolling, must present a copy of a valid Residence Permit ("Permesso di soggiorno") which must be requested within 8 days from the arrival in Italy.

6° STEP – DELIVER the requested documents in original

In case of academic qualification released abroad, **before the enrolment deadline** (which will be communicated by the Organizing Secretary) or **AT LAST by 10 January 2025**, you will have to deliver to our office:

- 1. **the original** of **ALL documents proving your education** (see STEP 1) necessarily comprehensive, at this point, of:
 - Declaration of Value/Statement of Comparability/Diploma supplement
 - OR Statement of Correspondance
- together with the legalization/apostille/Statement of Verification of the academic qualification
- together with the residence permit/card.

FEES

APPLICATION FEE

Within the 30th of September 2024 is necessary to pay 35.00 Euro to finalize the application procedure.

TUITION FEE

The Vocational Program's tuition fee is of € 15,000.00:

- 1° installment of € 10,000.00 to be paid on-line to finalize the enrolment procedure
- 2° installment of € 5,000.00 to be paid by 10 January 2025.

FINAL EXAM FEE

To be admitted to the final exam, candidates must submit a specific application form along with the payment of € **116.00** as a fee for the issuance of the Vocational Program's diploma.
