# 1. GENERAL INFORMATION

For the 2025/2026 academic year the University of Pavia offer a single-cycle master's degree program in Medicine and Surgery (taught in English) whose academic curriculum includes 360 credits in total, over six years.

The course has a limited number of places at national level and there is a single admission test provided by the Italian Ministry of University and Research (MUR).

Information on the admission test is available on the English-language Medicine and Surgery test webpage: <a href="https://portale.unipv.it/it/didattica/corsi-di-laurea/corsi-di-laurea-magistrale/medicine-and-surgery">https://portale.unipv.it/it/didattica/corsi-di-laurea/corsi-di-laurea-magistrale/medicine-and-surgery</a>.

The course has the following available places:

<sup>\*</sup> In absence of adequate applications, the places not covered by the Marco Polo quotas will be assigned to the Non-EU students' quota. Places not covered by the latter quota will be assigned to EU students and non-EU students residing in Italy.

The path leading to enrollment includes the following steps:

- ✓ register for the national entry test; the content is the same at all Italian universities and testing centers;
- √ take the entry test in English and obtain a minimum score (see <u>section 8</u>);
- ✓ appear in the ranking list:
  - EU and non-EU candidates residing in Italy: single national merit ranking ordered according to the score obtained by candidates, considering the places available in the various universities and the options expressed by candidates;
  - Non-EU residing abroad: university merit ranking ordered according to the score obtained by candidates.
- ✓ enrollment of those ranked in a position eligible for admission.

# 2. REQUIREMENTS FOR ENROLLMENT

In order to be enrolled in the Master's degree program in Medicine and Surgery (taught in English), applicants must have one of the following qualifications:

- > a high-school diploma
- > study qualification obtained abroad considered equivalent to an Italian school diploma verification of the diploma's eligibility prior to matriculation is mandatory in accordance with <a href="Section 4">Section 4</a> and <a href="Section 10.3">Section 10.3</a>.

In the event that the evaluation of the eligibility of the foreign degree has not been done, the admitted candidate cannot be enrolled.

# 3. HOW TO REGISTER FOR THE ADMISSION TEST

From August 26 to September 9, 2025, by 3 p.m. (GMT+2), by visiting the following website: www.universitaly.it and paying a fee. Candidates who do not respect the deadline of September 9, 2025 3 p.m. (GMT+2) for both online test registration and/or the fee payment will be excluded from the examination.

During the registration for the test, candidates must provide:

- the email address (it is advisable to check and communicate any changes immediately);
- the universities the candidates are applying to, in order of preference;
- if the candidate intends to take the exam at an Italian location, the university indicated as their first choice is also the location where they will take the exam;
- if the candidate intends to take the exam at a foreign location indicate in which center among those listed below (paragraph 3.1.);
- any language certifications candidates may have among those required (-> <u>D.M. 7 August 2025 N.</u>
   599, annex 3).

The choice of the universities for which to compete in order of preference and the location where to take the test cannot be changed after the 3pm (GMT+2) deadline of September 9, 2025; the last preference expressed will be used as a confirmation for the candidate's choice within the set deadline. **The candidate must take the test at the indicated location**, no exceptions allowed.

#### 3.1. Foreign admission test centers

#### 3.2. CANDIDATES WITH DIAGNOSED DISABILITIES

Candidates submitting a disability certificate or candidates who use external assistive devices, such as special glasses, hearing aids, etc., must indicate the aid used or the compensatory measures necessary in relation to their certified condition.

Candidates with disabilities as defined by Law No. 104/1992:

- must indicate any need for additional time to complete the competitive examination;
- must submit certification:
  - in original or certified copy on plain paper;
  - issued by a medical commission competent for the territory;
  - indicating the type of disability and/or degree of handicap recognized;
  - if issued in a foreign country, it must be legalized and accompanied by a sworn translation by an official translator or certified as conforming to the original text by the Italian diplomatic representatives in the country of residence, in Italian or English.

**Candidates diagnosed with specific learning disorders (SLD –** *in Italian DSA*), as referred to in Law No. 170/2010, must indicate their certified situation when registering for the competition:

- must submit the certification:
  - in original or certified copy on plain paper;
  - if prior to reaching the age of 18, it must have been issued no more than three years ago;
  - issued by National Health Service facilities or by specialists and facilities accredited with the regional health service;
  - if issued in a foreign country, it must be legalized and accompanied by a sworn translation by an official translator or certified as conforming to the original text by the Italian diplomatic representatives in the country of residence, in Italian or English.

Certificates must be sent via FILO DIRETTO (direct line) <a href="https://filodiretto.unipv.it/it">https://filodiretto.unipv.it/it</a> by September 4 - for the purpose of organizing the test. The University does not guarantee the arrangement of additional time and required aids for candidates who do not send their certification by September 4.

Candidates with disabilities who do not have an up-to-date medical certificate due to the limitations of the National Health Service caused by the Covid-19 emergency will be admitted to the exam; the University of Pavia reserves the right to request additional documentation at a later date.

# 4. HOW NON-EU CITIZENS RESIDING ABROAD CAN ENROLL FOR THE ADMISSION TEST

Non-EU candidates not regularly residing in Italy must:

- apply for a visa for study purposes by pre-registering through the <u>Universitaly portal</u> by August 31st,
   2025, and get the validation by the University of Pavia;
- go to the Italian diplomatic representations located in their country of residence to complete the procedure to apply for a visa for study purposes;
- request and obtain the evaluation of their school diploma on the application portal https://apply.unipv.eu/ from 26 August to 9 September 2025 (dedicated to applicants who have not yet obtained the evaluation of their school diploma for the Medicine and Surgery course for the academic year 2025/2026):
  - ✓ REGISTER at the link https://apply.unipv.eu/;
  - ✓ ATTACH:
    - Original diploma (or authorized copy or replacement certificate) for secondary school, obtained after at least 12 years of schooling, translated into Italian and legalized by the Italian diplomatic authorities in the country where the diploma was obtained or apostilled by the local authorities for countries adhering to the Aja convention of 05/10/1961 or with Statement of Verification issued by CIMEA (to be requested at this link: <a href="https://cimea-diplome.it/">https://cimea-diplome.it/</a>). In case the diploma is issued in English, Spanish or French, translations are not required. If legalization is not available at the time of application, it may be submitted at a later date, within the specified deadlines;
    - Declaration of value issued by the competent Italian diplomatic authority, or alternatively the
      Certificate of Comparability issued by CIMEA (request it at <a href="https://cimea-diplome.it/">https://cimea-diplome.it/</a>) or,
      alternatively, the Statement of Correspondence downloaded from the <a href="ARDI">ARDI</a> database; if the
      Declaration of Value or the CIMEA Certificate of Compatibility are not available at the time of
      application, they may be submitted at a later date, within the specified deadlines;
    - The certificate of passing the local exam for university entry if set by the country where the diploma has been obtained, to demonstrate the eligibility for the admission to the university;
- PAY the application fee of 35 € (not refundable). The payment must be carried by the day before the deadline [for reasons of back transactions, the system allows the submission of the application only after acquiring the payment]

The application is considered valid if it contains all the required documentation by the deadline.

register for the national entry test as indicated in paragraph 3.

# 5. DATE, PLACE AND TIME OF THE ADMISSION TEST

The admission test will take place on **September 17, 2025**. Time of admission into the room, the addresses of the test-taking centers and the rooms assigned to registered candidates will be published on September 15, 2025, after 3:00 p.m. on the <u>webpage with the information on the Medicine and Surgery national entry test</u>. At the University of Pavia, the exam begins at **11 a.m.** Candidates who arrive after the scheduled start time may be admitted to the exam room only if the Commission deems that there is sufficient time for identification, seat assignment, and delivery of exam instructions; late candidates will not be admitted to the exam room once the exam has begun.

# On the day of the test, candidates must bring with them:

- ✓ the receipt of confirmation issued at the end of the registration to the test on <u>www.universitaly.it</u>;
- ✓ ID:
  - valid make sure to check the expiration date;
  - non-EU candidates residing abroad must present a passport with a specific visa or an Italian Residence permit (or the receipt issued by the *Questura* attesting to the submission of the request for the Resident permit).

# 6. FORMAT AND CONTENT OF THE ADMISSION TEST

Candidates taking the test will be allotted **100 minutes**. The test is organized taking into account the needs of candidates with disabilities, in accordance with Law 170/2010 (130 minutes for candidates with DSA certification) and Law 104/1992 (150 minutes for candidates with L.104 certification).

The admission test consists of 60 multiple-choice questions with five alternatives, one of which is to be chosen (the other choices are wrong, arbitrary or less likely) on the following topics:

- reading skills and knowledge acquired during the studies (4 questions);
- logical reasoning and problems (5 questions);
- biology (23 questions);
- chemistry (15 questions);
- physics and mathematics (13 questions).

# 7. REGULATIONS GOVERNING THE ADMISSION TEST

Any violation of the following rules of conduct will result in the cancellation of the test:

- in cases where more than one examination room is used, candidates will be distributed by age, except for twins;
- candidates may not take the test in an examination room other than the one assigned, unless the variation has been authorized by the examination board and transcribed in the minutes;
- during the admission test, candidates cannot interact with anyone, except for the invigilators or the members of the Commission;
- candidates cannot consult any textbooks, copy or exchange material, including personal data sheets and answer sheets;
- candidates cannot keep bags or backpacks, and it is forbidden to carry in the classroom cell phones, palm-held electronic devices, smartphones, smartwatches, tablet, earphones or similar handheld devices, pens, pencils, stationary items (or other similar writing items), manuals, textbooks and their partial reproductions, handwritten notes, blank paper, consultation material as well as other electronic or communication devices;
- candidates must use only the black pen distributed by the test commission for compiling the answer sheet:
- the signing or marking of the answer sheet by the candidate or a member of the Commission will also result in a void exam;
- candidates cannot use personal pens, pencils or other writing material during the delivery of the
  personal data sheet and the answer sheet into the dedicated boxes, or use pens and pencils to edit,
  integrate or correct any part of the answer sheet.

Information on how to fill in the answer sheet and how to deliver the test to the commission:

- the candidate marks the chosen answer by placing an X mark in the corresponding box (drawing diagonals in the answer square box);
- candidates can correct only one answer, by completely blacken the previously given answer box and choose another answer; only one of the five possible options must be ticked so that the answer is clear;
- if a candidate decides not to answer a question, s/he must put a cross in the small circle on the answer sheet in correspondence to each question: once a cross has been put in the circle, no modifications can be made; if a candidate decide not to put a cross in the circle on the answer sheet in correspondence to each question and no mark appears in the answer boxes it will be considered as the candidate decided not to answer the question;
- when the test is over, the candidate must go to a dedicated desk located at a suitable distance from the test commission, where he will find a pen and on which are:

- a box for the delivery of the personal information sheet, where the facsimile of the personal information sheet appears on one side;
- the pairs of adhesive labels on which the barcodes are printed.
- at the dedicated desk the candidate must choose a pair of identical adhesive labels, verifying the correspondence between the two identical barcode labels. Each label must be placed at the candidate's own responsibility on the answer sheet and on the sheet with the candidate's personal information;
- candidates must complete the personal information sheet and must sign it when s/he delivers it, also
  for the declaration of correspondence of the codes of the labels applied to the personal information
  sheet and to the answer sheet;
- the use of personal pens, pencils or other writing material during the delivery of the personal information sheet and the answer sheet into the dedicated boxes, or the use of pens and pencils to edit, integrate or correct any part of the answer sheet will result in a void exam;
- finally, the candidate must place the personal information sheet into the sealed box at the dedicated
  desk and go to the commission desk to place the answer form in the dedicated, taking care to place the
  answer sheet flipped over so that answers cannot be visible.

# 8. TEST EVALUATION, RANKING AND MINIMUM PASSING SCORE

A maximum of ninety (90) points shall be awarded for the evaluation of the test, considering the following criteria:

- 1.5 points for each correct answer;
- 0.4 (-0.4) points for each wrong answer;
- 0 points for each blank answer.

<u>EU and non-EU students</u>, as stated in art. 39, subsection 5, law n. 286/1998 — the Interuniversity CINECA calculates the score obtained by each applicant to draw up a single national merit ranking. **Candidates that scored at least twenty (20) points** on the admission test are admitted according to the decreasing order of the obtained score, in the frame of the available places for enrolment in each course and expressed options when registering for the test. Non-eligible candidates (scoring less than twenty points) will not be placed on the ranking list.

<u>Non-EU applicants residing abroad</u> - A university merit ranking is drawn up. Candidates who have obtained a score higher than zero in the test are eligible for admission in descending order of the score obtained and within the available places. Candidates who have not answered any questions are not included in the ranking.

In the event of a tie score, the following criteria in order of priority will be applied to determine placement:

- the total points obtained on those questions relating to, in decreasing order:
  - biology;
  - chemistry;
  - physics and mathematics;
  - logical reasoning and problems;
  - reading skills and knowledge acquired during the studies.
- possession of language certificates with the following requirements:
  - one of language certificates listed in the <u>D.M. 7 August 2025 N. 599, annex 3;</u>
  - the candidate must have declared possession of the certification when registering for the test;
  - the candidate must be in possession of the official certification by September 9, 2025;
  - possession of the language certification is self-certified in accordance with Article 46 of Presidential Decree No. 445/2000;
  - the candidate must provide all the necessary elements to allow the University a verification of the truthfulness of the self-certification: in case of false or mendacious declarations any enrollment will be cancelled, with recovery of any benefits granted and without reimbursement of fees and university contributions paid, without prejudice to the penalties provided for by the Criminal Code

- and special laws on the subject and the exposure of the declarant to action for damages by the counterparties;
- ✓ in case of equal score between one or more candidates having a disability certificate equal or higher than 66% or disabled candidate having a certificate as stated by law n. 104 of 1992 art. 3, comma 3, and one or more candidates not included in the previously mentioned categories, the candidate having the disability certificate equal or higher than 66% or the disabled candidate having the certificate as by law n. 104 del 1992 art. 3, comma 3 will be given priority. The "assigned" candidate who wants to claim this preference must submit the certificate of disability equal to or greater than 66% or the certification referred to in Law No. 104 of 1992 Article 3, Paragraph 3, within 15 (fifteen) days from the assignment, otherwise s/he will be excluded from the national ranking. After this deadline, the undocumented preference title will not be considered;
- ✓ in case of further equal score, priority will be given to the officially younger candidate.

The eligibility status for the course of Medicine and Surgery is referred to the mere selection process; this selection does not imply any right to access to the course in years following the year in which the test was taken.

# 9. PUBLICATION OF RANKING LIST AND TERMS FOR ENROLLMENT FOR EU AND NON-EU STUDENTS RESIDING IN ITALY

On **25 September 2025** CINECA, on behalf of the Ministry, will publish only the score obtained by the candidates according to the label code on the webpage <a href="www.universitaly.it">www.universitaly.it</a> in accordance with the privacy regulations. The data will be available in the candidates' reserved area until procedures end.

On **6 October 2025** on the <u>Universitaly</u> portal, candidates will be able to view their exam, score and personal data sheet.

On 13 October 2025 on the <u>Universitaly</u> students' reserved area, the national merit name ranking will be published together with the name of candidates under the label "ASSIGNED" or "BOOKED" ["ASSEGNATI", "PRENOTATI"] to the course and university indicated as first preference; the university will receive the list of these candidates.

The operations of enrolment and the ranking list run as follows:

- 1. on 13 October 2025 the name ranking list will be published on the reserved area on the website of each degree course with indication for each candidate of score, position in the ranking and the University the student has been 'ASSIGNED' to, or considering the position in the ranking of all preceding candidates and the site preferences s/he can be 'BOOKED' or put in a 'WAITING LIST'. Please note that first useful preference means, in the order of the preferences indicated, the best option related to the location and course in which the candidate, based on the score obtained and the number of available places, is eligible to enroll;
- 2. candidates ASSIGNED to the University of Pavia must enroll according to the procedure described in the paragraph 10. Candidates BOOKED to the University of Pavia can decide to enroll or wait in order to get a better assignment-position. Candidates ASSIGNED and BOOKED can enroll in a maximum period of 4 days, excluding Saturdays, Sundays and holidays. Candidates ASSIGNED who do not respect the deadline of 4 days will not be allowed to enroll no matter what the reason for the delay. BOOKED candidates who do not use this option do not forfeit the ranking;
- 3. within 5 days from the deadline referred to in point 1. above, and in any case by noon of the fifth day following each ranking list scrolling, excluding Saturdays and holidays, each University, shall notify CINECA of the names of the enrolled students;
- 4. within 5 days from the deadline mentioned in point 1. above, and in any case by noon of the fifth day following each ranking list scrolling, excluding Saturdays and holidays, all candidates, with the exception

of enrolled and withdrawn, must confirm their interest in enrollment on their personal area of the Universitaly website. In the absence of confirmation, the candidate lapses from the national rankings in which s/he is placed and retains no right to enrollment.

No excuses for the missing of the deadline are accepted. Of this forfeiture, after the expiry of the deadline, automatic notice is given in the reserved area. Against this notice, without any further communication or challenge from the Ministry of University and Research, an appeal may be lodged to the Regional Administrative Court of Lazio within sixty days or to the President of the Republic within 120 days from the publication in the reserved area of each candidate; in the absence of an appeal against revocation within the time limits specified, an action against other grounds relating to the non-acceptance in one of the chosen degree courses shall not constitute revocation;

5. on **20 October 2025** CINECA, after receiving communication described in point 3., will publish an updated ranking list with the procedure described from commas 2. to 4.;

6. the following updates of the ranking list have the same procedures and time frames reported in commas 2., 3. e 4.

The publication of the ranking on <u>www.universitaly.it</u> will be considered the official communication of the results to the candidates.

Candidates will not be personally notified of their placement, and it is the candidate's responsibility to check his or her position in the national ranking list throughout the whole competition process and, if eligible, act as mentioned to proceed with enrollment.

At the end of the rankings' updates and in the absence of eligible candidates in the merit rankings who can enroll in the first year of the course, if the University of Pavia should have residual educational capacity, any applications for change of location, submitted for serious reasons duly documented, will be evaluated.

# 10. ENROLLMENT PROCEDURE OF EU STUDENTS AND NON-EU STUDENTS RESIDING IN ITALY

10.1. ADMITTED CANDIDATES NOT ENROLLED IN ANOTHER COURSE OF PAVIA UNIVERSITY

The admitted candidates, who are not already enrolled in another degree course of the University of Pavia, must proceed as follows, in strict accordance with the deadlines mentioned in paragraph 9.:

- 1. registration at the University of Pavia portal (student area) and at the specific section dedicated to the candidates who have passed the Medicine and Surgery test and are eligible to enroll;
- 2. finalization of enrollment and payment of tuition fees.

# 10.1.1. Registration at the University of Pavia's student area

- access the link <a href="https://studentionline.unipv.it/AddressBook/ABStartProcessoRegAction.do">https://studentionline.unipv.it/AddressBook/ABStartProcessoRegAction.do</a> and register to obtain your login credentials: username and password;
  - this step is not necessary if you already have credentials to access the Student Area of the University of Pavia;
  - in case of loss of your credentials, you must request a new password according to the instructions available on the web page: <a href="https://studentionline.unipv.it/Anagrafica/PasswordDimenticata.do">https://studentionline.unipv.it/Anagrafica/PasswordDimenticata.do</a>;
- access your Student Area with your credentials, select the menu item SEGRETERIA > TEST DI AMMISSIONE (ADMISSIONS > ADMISSION TEST), choose the dedicated competition Abilitazione candidati ammessi all'immatricolazione Medicine and Surgery and complete the procedure.

# 10.1.2. Finalization of enrollment

# 10.2. Transfer request to the first year

In case the candidate is already enrolled in another degree course of the University of Pavia, they will need to submit a transfer request to the first year of the Master's Degree in Medicine and Surgery, following the instructions below, in strict accordance with the deadlines mentioned in section 9:

- ✓ pay the first tuition fee for the enrolment into the academic year 2025/2026 (for applicants who did not already pay the first fee);
- ✓ log in to their Student Area and select the option CARRIERA>PASSAGGIO DI CORSO and submit the transfer request for the selected course;
- ✓ pay the fee of € 16 for the digital revenue stamp by the deadline.

The dedicated offices, once received the transfer request and the payment, will edit the enrollment of the candidate for the course selected in their transfer request; students can check the change of their enrollment for the selected course in their Student Area. From this moment on, students cannot take profit exams related to the previous study course. Exams of the new course can be taken only after having received the result of the previous academic career recognition.

#### 10.3. Transfer request from another university

Candidates admitted as transfers from other universities must, by the assigned deadline:

- ✓ enroll according to the procedures described, selecting the "transfer in" admission option
- ✓ pay the enrollment fee plus the virtual stamp duty of €16 for the incoming leave by the indicated deadline.

#### 10.4. APPLICANTS WITH FOREIGN DIPLOMA

In addition to following the procedure described in <u>paragraph 10.1.</u> or <u>paragraph 10.2.</u> above, it is mandatory to obtain title eligibility prior to the completion of the enrollment (<u>paragraph 2)</u>, by following the instructions below:

- ✓ Attach to their student area:
  - Original diploma (or authorized copy or replacement certificate) for secondary school, obtained after at least 12 years of schooling, translated into Italian and legalized by the Italian diplomatic authorities in the country where the diploma was obtained or apostilled by the local authorities for countries adhering to the Aja convention of 05/10/1961 or with Statement of Verification issued by CIMEA (to be requested at this link: <a href="https://cimea-diplome.it/">https://cimea-diplome.it/</a>). In case the diploma is issued in English, Spanish or French, translations are not required. If legalization is not available at the time of application, it may be submitted at a later date, within the specified deadlines;
  - Declaration of value issued by the competent Italian diplomatic authority, or alternatively the Certificate of Comparability issued by CIMEA (request it at <a href="https://cimea-diplome.it/">https://cimea-diplome.it/</a>) or, alternatively, the Statement of Correspondence downloaded from the <a href="https://cimea-diplome.it/">ARDI</a> database; if the Declaration of Value or the CIMEA Certificate of Compatibility are not available at the time of application, they may be submitted at a later date, within the specified deadlines;
  - The certificate of passing the local exam for university entry if set by the country where the diploma has been obtained to demonstrate the eligibility for the admission to the university;
- ✓ pay the application fee of 35€ that will be available in the Applicant's Private Area after the candidate has attached the above-mentioned documents and has completed the enrollment procedure.

Any available places are published on 27 October 2025 with the list of next eligible for enrollment candidates who must enroll by 30 October 2025 11.59pm. Non-EU candidates with a position in the ranking list not sufficient to enroll may send a "booking request" to the email address admission@unipv.it from 27 October to 30 October 2025 expressing their interest to enroll in case of any available places still remaining after the end of enrollment of admitted candidates. Make sure to indicate in the subject line of the email: "Interest in Admission - IMAT". In case of a vacancy, candidates will be notified via email by the Admission Office.

Candidates belonging to the non-EU residing abroad quota and Marco Polo project quota from other Italian universities, who have not enrolled in their first-choice location, can send a request to the Admission Office <a href="mailto:admission@unipv.it">admission@unipv.it</a>, from 27 October to 30 October 2025, to request reassignment to the University of Pavia; in the subject line of the email indicate "Reassignment from another University- IMAT".

Certification of the obtained score in the admission test must be attached to the email. On 5 November 2025 any remaining available seats will be published and assigned in order of merit according to the score obtained in the test to applicants from other universities who have requested so as above mentioned.

In case a candidate resident abroad and eligible to enroll within the non-EU category has a second citizenship from an EU country, the candidate will have the right to enroll revoked and will be excluded from the ranking of non-EU candidates residing abroad.
